The qualification, experience and age limit for the above post are as under:

- Essential Qualification & Experience: Bachelor's degree with at least 5 years relevant security supervisory experiences in Government or in a reputed organization. Should be well conversant with security matters and procedure to deal with local police and the general public.
- Desirable: Persons served in supervisory rank in defence/paramilitary services or Officers
 holding analogous posts having NCC Certificate and firefighting training. Experience on
 security of residential educational campus, computer knowledge and familiarity with Indian
 Laws. The requirement of Bachelor's degree will not be insisted in the case of candidates who
 have joined Armed Forces through NDA.
- Age: Preferably below 35 years.

General Instructions
