### 1. Introduction:

Outsourcing and contract management are integral part of today's competitive business world, whose importance are well-acknowledged. Outsourcing helps an organization to improve flexibility and focus on core activities, and develop competitive advantage. Outsourcing non-core activities enables an organization to leverage their suppliers' strengths and thereby increase its ability to deliver value to its customers. However, effective outsourcing requires both strategic and tactical analysis based on special competency of human resources involved in purchasing, materials management, stores, supply chain, and other related areas. Therefore, understanding of contract and relationship management techniques, tools, and collaboration is essential to meet the strategic goals and objectives of an organization.

Contract management is the process of systematically and efficiently managing contract creation, execution, and analysis for the purpose of maximizing financial and operational performance and minimizing risk. It emphasizes on forging work relationships with customers, vendors, partners, employees and other stakeholders, and encompasses negotiating the terms and conditions in contracts and ensuring compliance, documenting and agreeing on any changes or amendments that may arise during its implementation.

### 2. **Program Objectives**:

The program aims to provide basic understanding of the dynamics involved in managing outsourcing and contract management functions. It encompasses managing outsourcing and inter-organizational relations, contracts and procurement including timely delivery with desired quality at specified/agreed performance requirement. It emphasizes on empowering supply professionals to foster synergistic opportunities and developing special skills to face the challenges. The course will help the participants - working professionals and managers to develop outsourcing and contract management skills, and apply it to their work to meet the need of the organization.
