# RISK ASSESSMENT OF OCCUPATIONAL EXPOSURE TO NOISE AND VIBRATION IN MINES

(September 22-26, 2020)

#### Organized by Department of Mining Engineering, IIT Kharagpur

The unprecedented COVID-19 pandemic has adversely affected every sphere of life including the Mining industry. It has disrupted the usual industrial operations and there is no certainty when things will become normal. Even in these tough and challenging times of lockdown and social distancing, mining operations should continue to support the economy and life in general. Our concern for safety and occupational health of miners has become more important and relevant in the current scenario.

We draw your attention to **occupational exposure t o n oi s e** due to deployment of mining machinery and plant operations. This is considered as major health hazard affecting millions of mine workers as well as the residential areas in and around the mining complexes. Noise Induced Hearing Loss (NIHL) is also considered now as Notified Disease under Section 25 of the Mines Act, 1952. On the other hand, operators of earth-moving machines are regularly exposed to harmful **whole-body vibration** (WBV). Many of them (~85% in one study) are already suffering from LBP (low-back pain). In mining operations there can be a combination of relatively high intensity of vibration and long exposure durations at work. Effective risk mitigation requires understanding of the main aspects of a risk that pose a hazard to health.

Directorate General of Mines Safety (DGMS) has circulated the Recommendations of X<sup>th</sup> and XI<sup>th</sup> Conferences on Safety in Mines wherein Noise Mapping in mines and Vibration studies of mining equipment have been made mandatory. Not only for **statutory compliance but** also for serving the mining community in a better way, the mines require enhancement of theoretical and practical knowledge in these fields. In view of the above and considering the situation due to the pandemic, Department of Mining Engineering IIT Kharagpur is organizing a 5-days online course/Web Training on *Risk Assessment of Occupational Exposure to Noise and Vibration* which is specially designed for *Indian mines*.

# **Objectives**

- To develop knowledgeable and trained manpower within the mining industry for Noise and Human Vibration monitoring and health risk assessment
- To disseminate knowledge on Noise Mapping software and technologies for application in mining projects.

# The following broad areas will be covered in the course:

- Impact of noise on mining and surrounding areas
- Area noise monitoring and personal noise dosimetry in mines
- Noise Mapping in mines: World best practices
- Whole-body vibration: assessing health risks as per ISO Standards
- Introduction to Noise Mapping theories and best international practices
- Online interactive demonstration on noise monitoring, noise mapping (Equipment & Software)
- Online interactive demonstration on equipment vibration instrumentation and data analysis

The online course will be conducted during **September 22-26, 2020** from 10:00AM to 5:00PM with lunch and tea breaks preferably through **Google Meet**. Video recordings of lectures with practical demonstrations, soft copy of the course materials and **Certificate of Participation** will be emailed to the registered participants. The effectiveness of this online course will be evaluated through **two online examinations** (short question/MCQ type) of the participants.
