- Content: must clearly outline the research problem, objectives, methodology, and key findings
- Keywords that describe the submission.
- Submissions must be accopmained by the following declaration: "I/We confirm that the submitted manuscript is my/our original work and has not been previously published or under consideration for publication elsewhere, either in part or in full."
