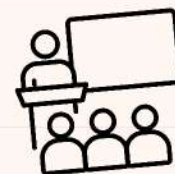

ELIGIBILITY CRITERIA

The Conference is open to all PG Students, Research Scholars, Industry Professionals and Academicians. PG Students refers to those pursuing Masters in Law, Science, Humanities, Business and Masters any other relevant discipline.

✓ **Paper Presentation and Conference-** The Conference and its events are also open to International Post Graduate students. UG Students can participate in the paper presentation only if their co-author and co-presenter meets the above-mentioned eligibility criteria.

✓ **Short video making competition and Policy Drafting competition-** This is open to all UG and PG students.

REGISTRATION FEES

Common Registration fee for all events (only one fee for any combination of events):

- **Students and Research Scholars:** Rs. 3000
- **Faculty:** Rs. 4000
- **Industry:** Rs. 5000
- **International Students:** 50\$
- **Students only attending without presentation or paper submission:** Rs. 2000

Upon registration, a participant can participate in more than one event in any combination, provided their schedules do not coincide with one another. All registered participants will be eligible for a free e-copy of the Conference proceedings.

Only Individual Registrations per participants are permitted. In case of co-authorship, each participant has to register separately and pay the fee individually.

SUBMISSION GUIDELINES

I. ABSTRACT

The submission shall be made in doc/docx file by 5th February, 2026. The word limit for the abstract is 400 words, including five keywords. The abstract should mention the following aspects of the paper:

- Problem Statement
- Objective
- Methodology
- A brief outline of the paper (tentative).

The document should also contain Author details: Name, Institution, Designation (Year), Contact number, Email ID.

The font shall be Times New Roman, Font Size - 12, Line Spacing - 1.5, and in justified format. AI-Generated content will not be accepted and the authors have to give an undertaking mentioning that the content is not AI generated.

II. EXTENDED ABSTRACT

The submission of the extended abstracts for selected abstracts is to be made on 28th February, 2026. The manuscript should be original and unpublished. The maximum word limit for the extended abstract is 8000 words, including footnotes.

The extended abstract should follow the following formatting guidelines:

- The submission shall be in a doc/docx file.
- The font shall be Times New Roman, Font Size - 12, Line Spacing - 1.5, and in Justified format.
- All citations will be made using the Harvard referencing style (author-date).
- References should be provided only at the end of the extended abstract.

All authors must use a similarity index tool, such as Turnitin, and submit a similarity report of the extended abstract. In case words are excluded while checking the report, a maximum of 5 words would be excused. Acceptable plagiarism limit is 10%.

AI-generated content will not be accepted.

The authors at the end of the extended abstract have to give an undertaking mentioning that the content is original and not AI-generated.

III. SHORT VIDEO MAKING COMPETITION

The submissions must be made by 15th February, 2026, and must adhere to the theme: **"IP and Sports"**. The duration of the video must not exceed 3 minutes and it must not include any obscene language, words, remarks, gestures.



IV. POLICY DRAFTING COMPETITION

The policy drafting competition will be on the theme: **"Intellectual Property and Climate Change"**. The policy submission will be in two phases: The first for a brief or abstract that explains the basic features and objectives of the policy at the time of registration. The final submission will as per the date announced.

The participants will have to submit the elaborate policy brief of not more than 4000 words by 1st March 2026. The draft must be clear, concise and target the specific agenda.

The final presentation shall be conducted on 15th March, 2026 and the panel's decision will be based on the written and oral submissions of the participants (60% and 40% respectively). Each team will be given 10 minutes to present their policy to the panel.
