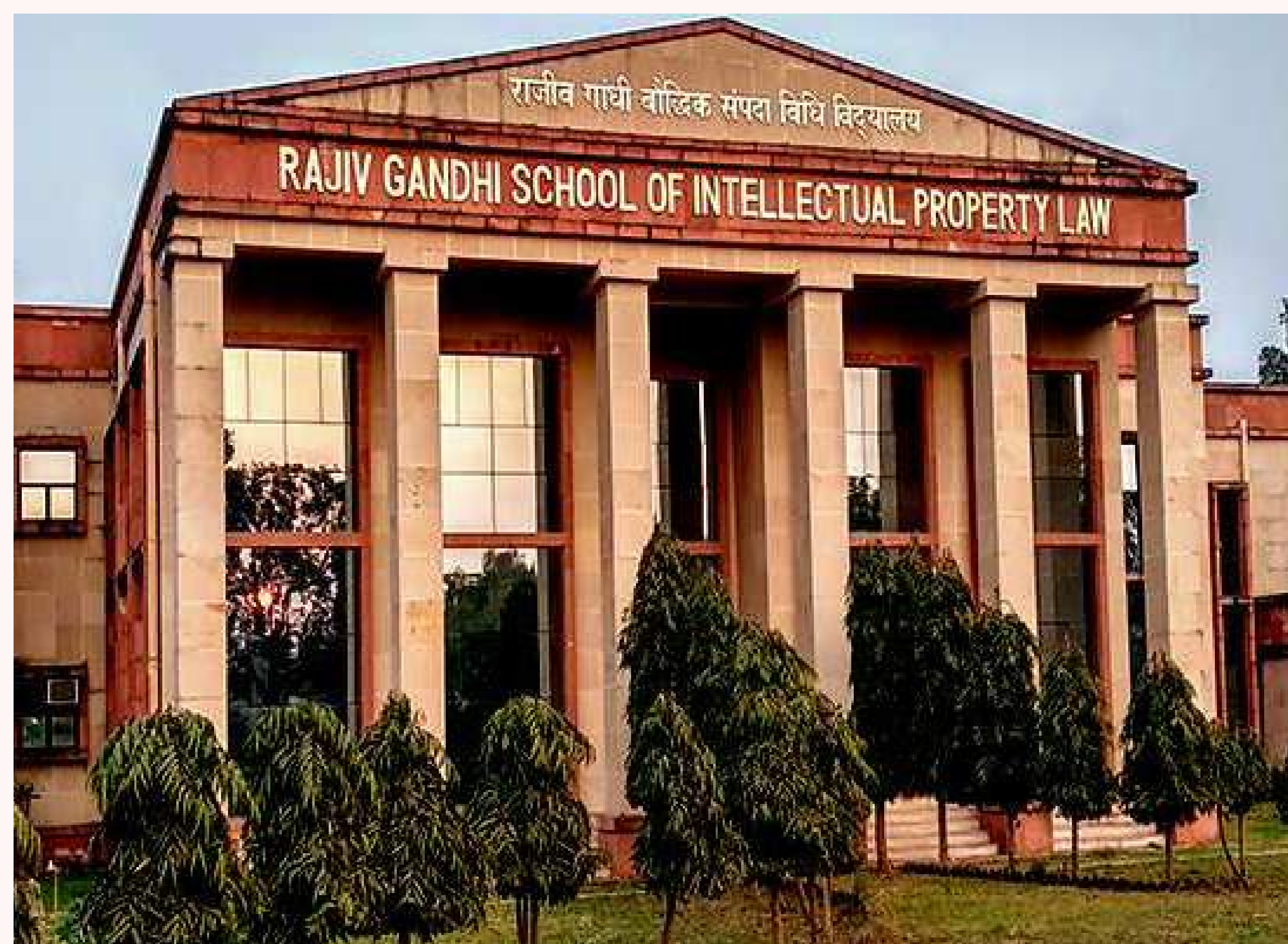

SUBMISSION GUIDELINES

A) ABSTRACT

- The submission for the abstract is to be made on **February 10, 2023**.
- The submission shall be in doc/docx file.
- The maximum word limit allowed for the abstract is 300 words inclusive of five keywords.
- The abstract should mention the following aspects of the paper:
 1. Author details: Name, Institution, Designation (Year), Contact number, Email ID,
 2. Problem Statement,
 3. Objective,
 4. Methodology,
 5. A brief outline of the paper (tentative).
- The font shall be Times New Roman, Font Size - 12, Line Spacing - 1.5 and in Justified format.
- Abstract shall be submitted at mcip@iitkgp.ac.in

B) FULL PAPER

- The submission for the full paper is to be made on **February 28, 2023**.
- The manuscript should be original and unpublished.
- The maximum word limit allowed for the full paper is 8000 words, including footnotes.
- The paper should follow the following formatting guidelines:
 1. The submission shall be in doc/docx file.
 2. The font shall be Times New Roman, Font Size - 12, Line Spacing - 1.5 and in Justified format.
 3. All citations are to be made using the Harvard referencing style (author-date).
 4. References should be provided only at the end of the paper.
 5. All the authors are required to use any of the similarity index tools such as Turnitin and submit a report of the similarity report of the full paper.
- Co- authorship is allowed to the maximum of two authors.

ESSAY WRITING COMPETITION

In the MCIP 3.0, we are coming up with an “Essay Writing Competition” under the theme, “IP AND YOUTH: ADVOCATING FOR INNOVATION.” We have wisely chosen the theme, as it helps in offering a plethora of non-exhaustive sub-themes.

The topic for the essay writing competition will be disclosed on March 10 2023.

SUBMISSION GUIDELINES

1. The submission for the Essay is to be made on **March 20, 2023**,
2. The word limit is 3500-5000 words, including footnotes,
3. The manuscript should follow the following formatting guidelines:
 - The submission shall be in a doc/Docx file,
 - The font shall be Times New Roman, 12 font size, 1.5 spacing, and justified,
 - All citations are to be made using the Harvard referencing style (author-date),
 - References should be provided only at the end of the paper.
4. All the authors are required to use any of the similarity index tools such as turnitin, and submit a report on the similarity report of the full paper.

POLICY MAKING COMPETITION

The competition provides a platform where the best minds can come forward and critically utilize this opportunity of curating and drafting policies. The aim is to design policies that bring welfare to society by promoting and protecting every section. This way, the innovations will also reach the most marginalized sections of society.

The theme and structure of the policy-making will be disclosed on March 10, 2023.

SUBMISSION GUIDELINES

1. The submission for the policy making is to be made on **March 20, 2023,**
2. Students can form a team for this competition. The team shall not be of more than three members,
3. Each policy paper must target the agenda,
4. The committee, after a thorough screening process, shall select the top policy papers,
5. Each term shall have a maximum of ten minutes to present their ideas.
