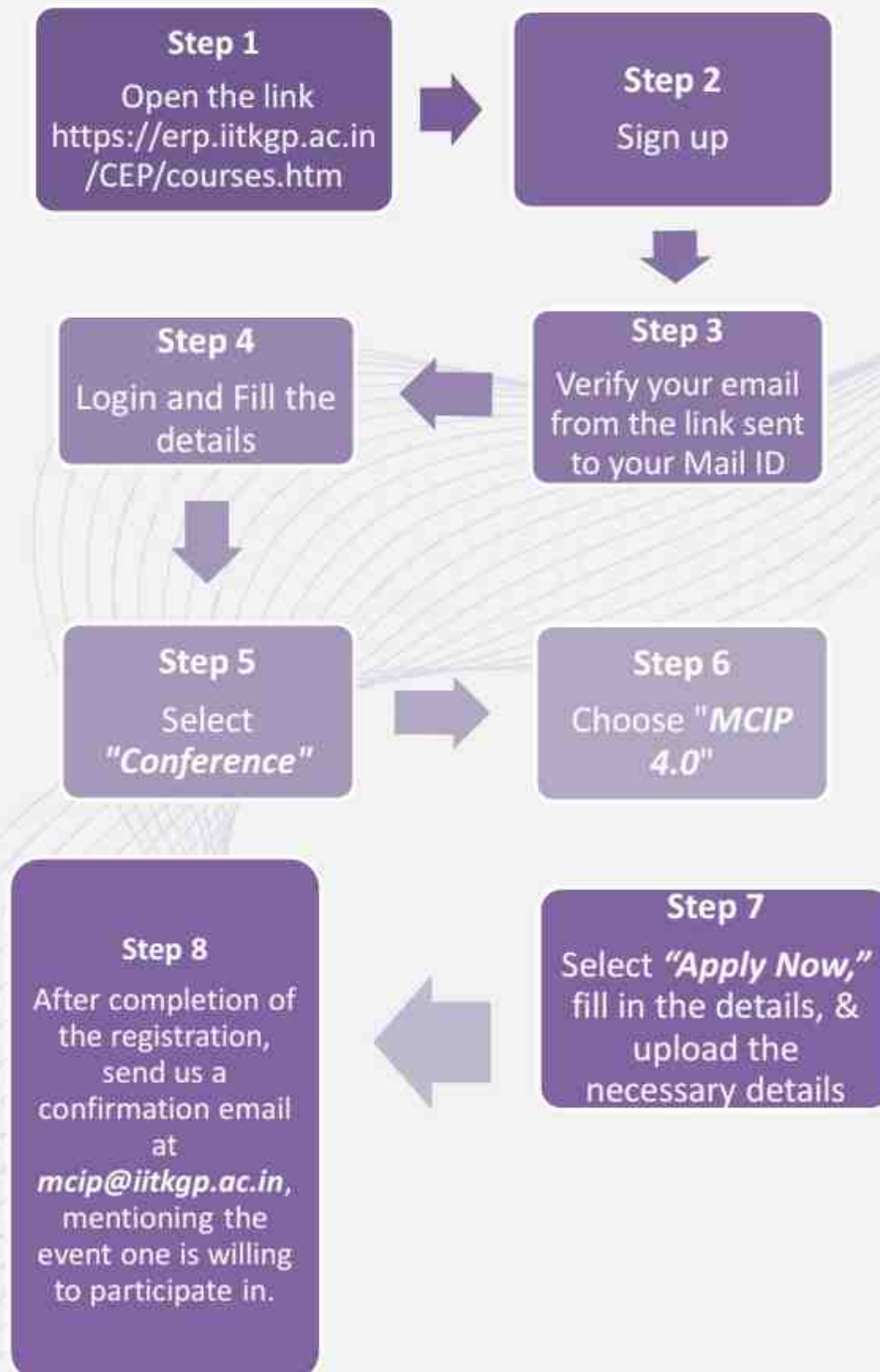

SUBMISSION GUIDELINES

I. ABSTRACT

The submission for the abstract is to be made on *January 27, 2024*.

The submission shall be in a doc/docx file.

The maximum word limit for the abstract is 300 words, including five keywords.

The abstract should mention the following aspects of the paper:

- The Author details: Name, Institution, Designation (Year), Contact number, Email ID
- Problem Statement
- Objective
- Methodology
- A brief outline of the paper (tentative).

The font shall be Times New Roman, Font Size - 12, Line Spacing - 1.5, and in justified format.

The abstract shall be submitted to *mcip@iitkgp.ac.in*.

II. FULL PAPER

The submission of the full paper for selected abstracts is to be made on *February 29, 2024*.

The manuscript should be original and unpublished.

The maximum word limit for the full paper is 8000 words, including footnotes.

The paper should follow the following formatting guidelines:

- The submission shall be in a doc/docx file.
- The font shall be Times New Roman, Font Size - 12, Line Spacing - 1.5, and in Justified format.

All citations will be made using the Harvard referencing style (author-date).

- References should be provided only at the end of the paper.
- All authors must use any similarity index tool, such as Turnitin, and submit a report of the similarity report of the full paper.

MINORITY OPINION (IP JUDGMENTS)

In MCIP 4.0, we are coming up with "Minority Opinion" under the theme, "IP AND ACCESS." We have wisely chosen the theme, as it helps in offering a plethora of non-exhaustive sub-themes.

The Judgments for the Minority Opinion (IP Judgments) will be disclosed along with the registration forms.

SUBMISSION GUIDELINES

The Participants will be given one judgment, which will be disclosed on **January 30, 2024.**

The submission for the Summary of Arguments is to be made on **February 29, 2024.**

The minimum word limit is 1500 words, including footnotes.

The Summary of Arguments should follow the below-mentioned formatting guidelines:

- The submission shall be in a doc/Docx file.
- The font shall be Times New Roman, 12 font size, 1.5 spacing, and justified.
- All citations will be made using the Harvard referencing style (author-date).

POLICY MAKING

The event provides a platform where the best minds can come forward and critically utilize this opportunity to curate and draft policies. The aim is to design policies that bring welfare to society by promoting and protecting every section. This way, the innovations will also reach the most marginalized sections of society.

The theme and structure of the policymaking will be disclosed on January 27, 2024.

SUBMISSION GUIDELINES

- The submission for the policymaking is to be made on **February 29, 2024**. Participants can form a team for this event. The team shall comprise a minimum of two and a maximum of three members.
- Each policy paper must target the agenda.
- The panel's decision will be based on the written and oral submissions of the participants.

Each team shall have a maximum of ten minutes to present their policy.

ACCOMMODATION

Participants will have to arrange their own accommodation however, the event organizers may assist on a case to case basis on request where the participants will bear the payment.

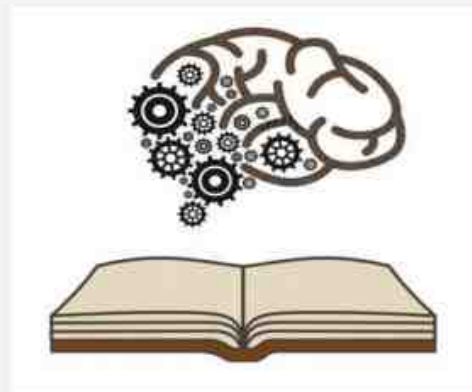
