All students who are interested to avail tuition fee waiver/ MCM and any other scholarship or awards and prizes related to family income should keep their family income documents ready for uploading in ERP for verification.

The deadline for uploading the family income documents is 31st October 2022.

For Tuition fee waiver:

All students who would like to avail tuition fee waiver must upload family income document for **Financial Year 2021-2022**.

If the full fee is paid before the verification of the family income document, the excess amount arising out of the fee waiver will get adjusted of spring semester 2022-2023.

In the event of not verifying the income document the student will be charged full tuition fee for **Autumn and Spring Semesters for the session 2021-2022.**

For MCM/Endowment MCM Scholarships:

Students who want to avail Institute MCM or Endowment Scholarships or any awards and prizes must upload their family income documents in ERP and get it verified by Academic Section for Financial Year 2021-2022 in the ERP.

No further document will be allowed to upload after the deadline.

For all other outside Scholarships, Loans, Interest subvention etc. related to Family Income:

Students (<u>including SC/ST/PD</u>) who want to avail scholarships through Central/State Govt. schemes or Private agencies where Income is a criteria must upload their family income documents in ERP and get it verified by Academic Section for **Financial Year 2021-2022**.

Family income documents to be submitted:

Student must submit a family income document as per **Annexure - I** along with an affidavit as per **Annexure - II**.

Alternatively, Form-16 / ITR of Both Parents can also be uploaded as family income document

The Issuing authority of Family Income Document must be a local District Authority like S.D.O./B.D.O./Tahasildar/Mondal Revenue Officer (MRO).

All income documents should be issued for the Financial Year 2021-2022.

In all documents the Financial year 2021-2022 should be clearly mentioned. Date of issue of the certificate will not be considered as indication of Financial Year, unless or otherwise certified by the issuing authority.
